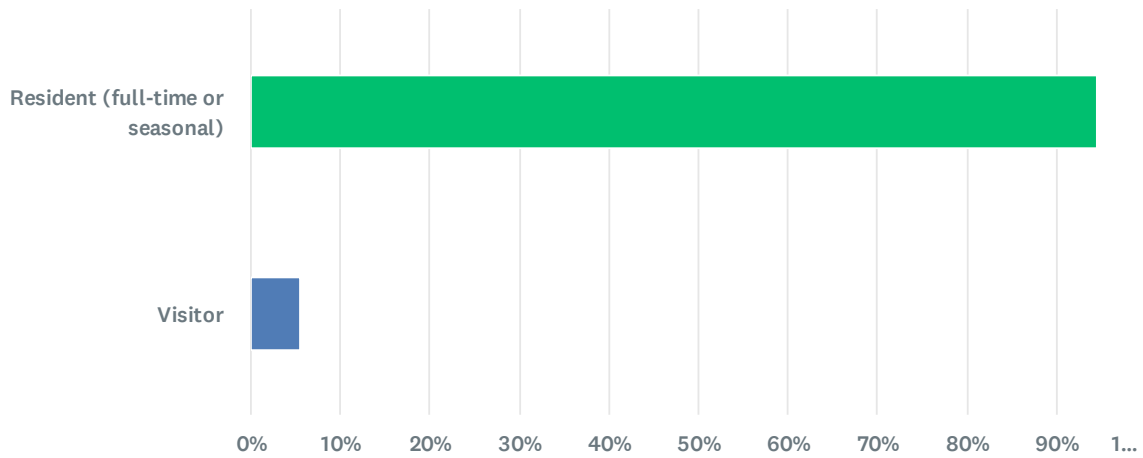


Q1 Are you a resident or visitor?

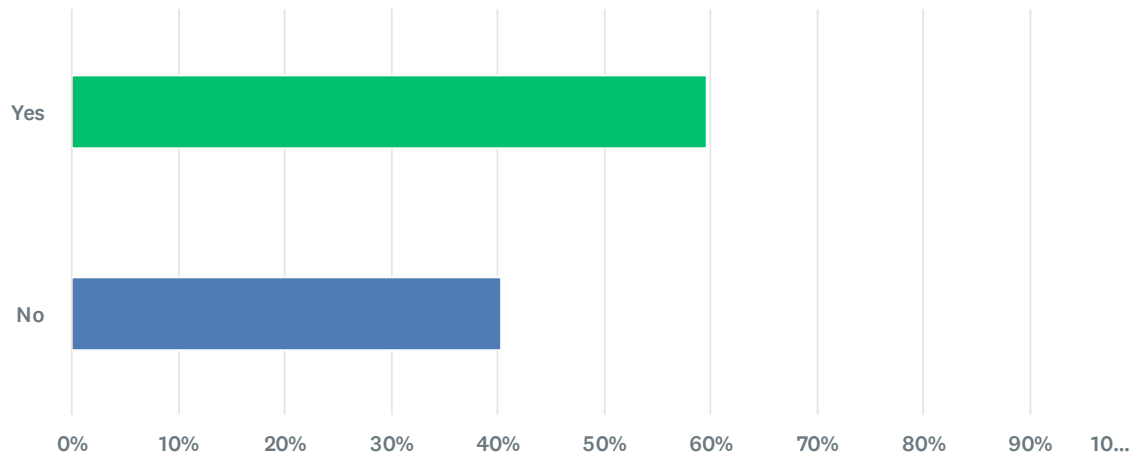

Q2 Are you a dog owner?

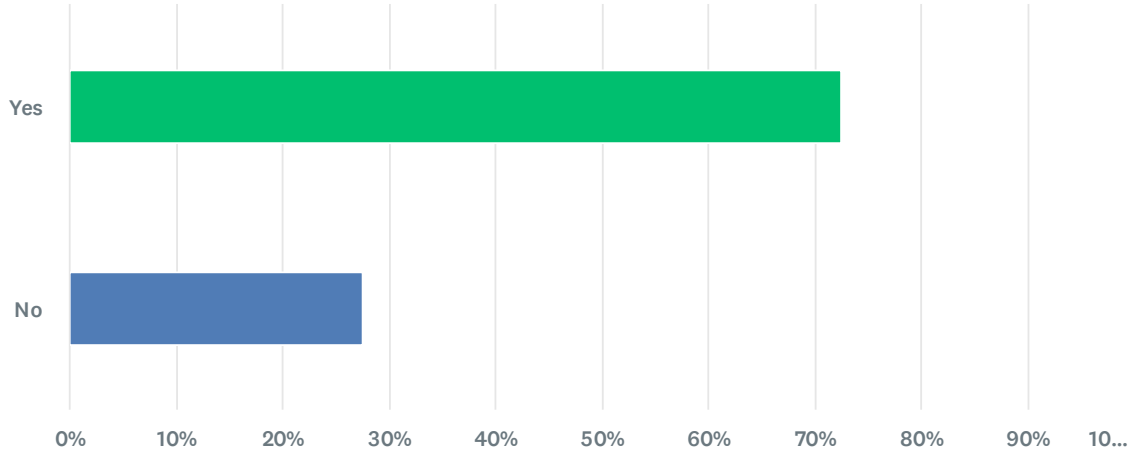

Q3 Do you think dogs should be allowed on grass areas in public parks (on leash and under control)

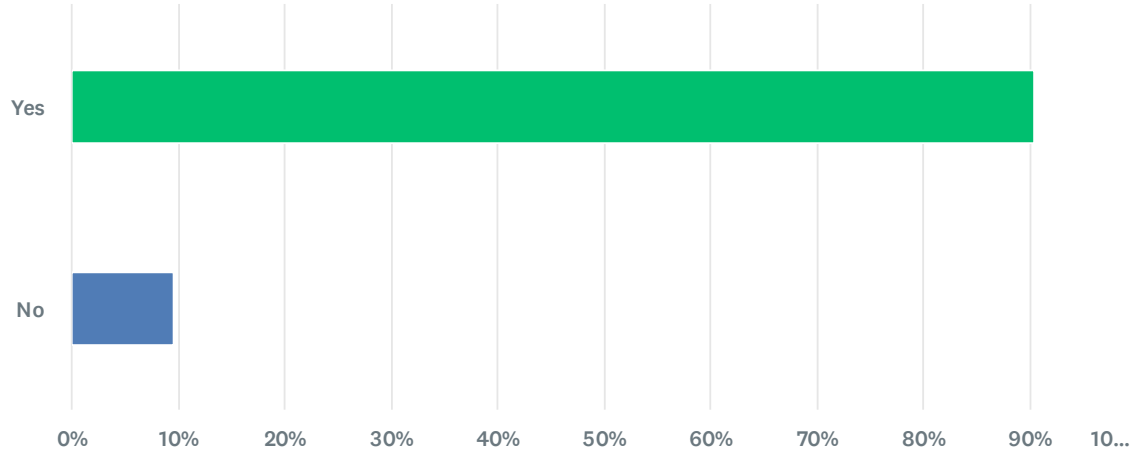
