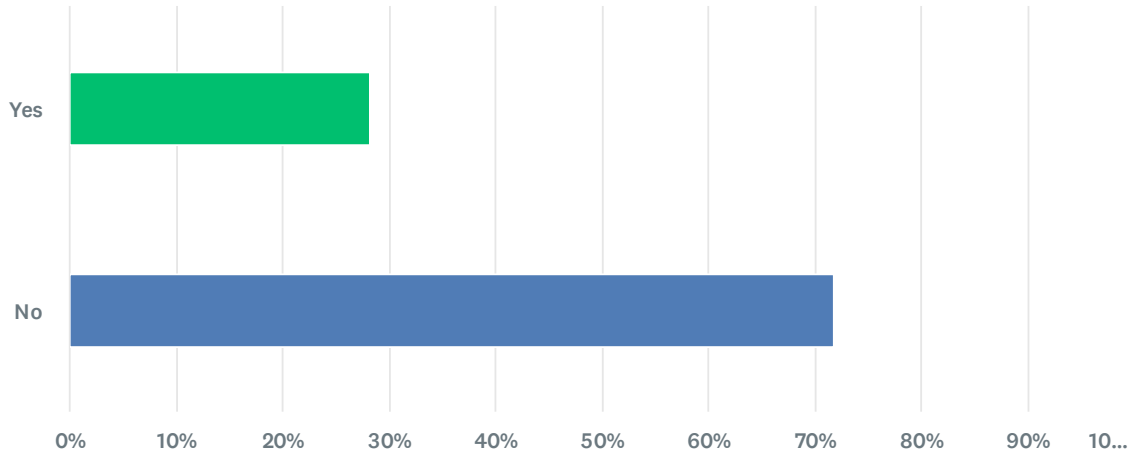


Q1 Do you feel metal storage containers should be allowed on properties zoned as residential?

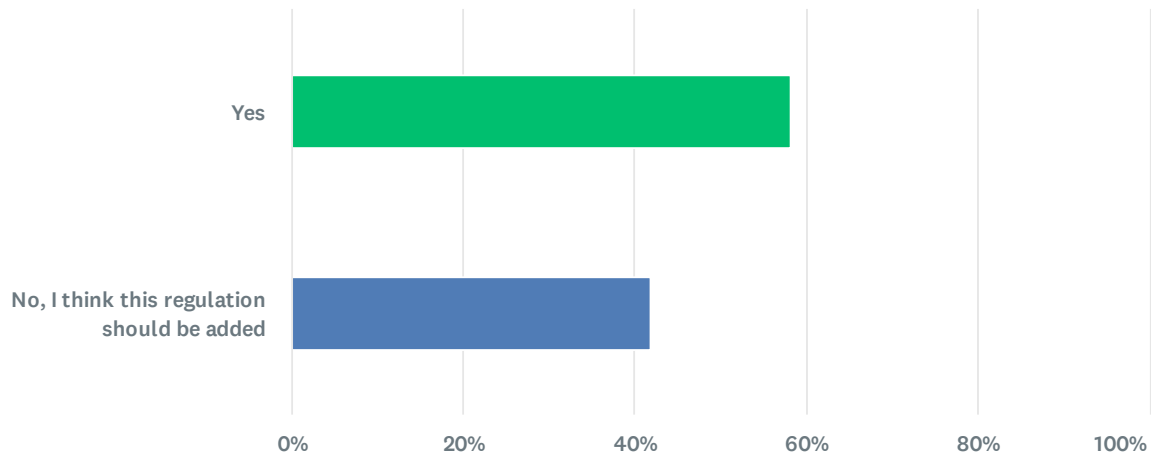
